



Supporting Education of Youth in Substitute Care:

Resources and References



- Start talking to youth about 2-year or 4-year colleges in middle school.
- Remember that teen may have been traumatized in several ways.
- Consider school transportation issues and how that might affect youth's development.
- Ensure youth are taking college preparation courses.
- Hold Best Interest Determination (BID) meetings.
- Connect youth to LINKS to get exposure to college and independent living skills.
- Encourage youth to participate in extracurricular activities if possible to give youth exposure to another aspect of school.
- Ensure youth are getting the services they qualify for at school.
- Support and provide resources for LGBTQ+ youth, Check out our LGBTQ+ Youth in Foster Care Brochure for resources.

- Consider school transportation issues and how that might affect youth's development.
- Remember that teen may have been traumatized in several ways.
- Support and provide resources for LGBTQ+ youth, Provide them with the LGBTQ+ Youth in Foster Care brochure
- Help youth discover strengths to increase self-esteem and confidence and to decrease negative self-talk.
- Help youth find educational and mental health resources if learning is affected by internal emotions and behaviors.

- Hold Best Interest Determination (BID) meetings.
- Empower foster parents to be educational advocates for the youth.
- Invite school reps to CFT or have CFT at school (school social workers, guidance counselors, dropout prevention specialists, educational liaisons, or specialists) to ensure education is a priority.
